Altera dispositivos da Lei n.º 2.885, de 25 de maio de 2005, que “altera dispositivo da Lei n.º 2.297, de 25 de maio de 2005, que “reestrutura o Regime Próprio de Previdência Social do Município de Unaí (MG) e dá outras providências.”

O PREFEITO DO MUNICÍPIO DE UNAÍ, Estado de Minas Gerais, no uso da atribuição que lhe confere o artigo 96, inciso VII da Lei Orgânica do Município, faz saber que a Câmara Municipal de Unaí decreta e ele, em seu nome, sanciona e promulga a seguinte Lei:

Art. 1º O Anexo I da Lei n.º 2.885, de 11 de dezembro de 2013, passa a vigorar com a redação dada ao Anexo Único desta Lei.

Art. 2º O artigo 2º da Lei n.º 2.885, de 2013, passa a vigorar com a seguinte redação:

“Art. 2º Fica instituído o Plano de Amortização para Equacionamento de Déficit Atuarial do Regime Próprio de Previdência Social do Município de Unaí – Paeda/RPPS –, através de aporte financeiro periódico, para cobertura de déficit técnico, apurado no parecer constante da avaliação atuarial realizada para o exercício de 2014 e consubstanciado nas parcelas mensais de amortização e respectivos valores fixados para cada patrocinadora, discriminados no Anexo Único desta Lei.”

Art. 3º Esta Lei entra em vigor na data de sua publicação, retroagindo seus efeitos a 1º de junho de 2014.
